**July 2018 Supervisor Note (Detention) Inspection**

Inspection Report# BI2018-0086

The Audits and Inspections Unit (AIU) of the Bureau of Internal Oversight (BIO) will conduct Blue Team Supervisor Note entry inspections on a monthly basis. The purpose of the inspection is to ensure compliance with Office policies and to promote proper supervision. To achieve this, inspectors will select for review the Supervisor Note entries for 35 randomly selected Detention personnel for the month being inspected. To ensure consistent inspections, the Supervisor Note Inspection Matrix developed by the AIU will be utilized.

**Matrix Procedures:**

Utilize the Supervisor Note Inspection Matrix to ensure that each randomly selected employee received one Supervisor Note entry during July 2018, and that the Supervisor Note was of sufficient quality to document the employee’s work performance (reflects the employee’s positive traits, accomplishments, any observed shortcomings, and can be used to facilitate the preparation of an accurate and detailed performance review) and that the selected employees’ EIS information was reviewed.

**Criteria:**

MCSO Policy GB-2, *Command Responsibility*

**Conditions:**

A review of the IAPro records revealed that, of the 35 employees’ records reviewed for Supervisor Note entries submitted during the month of July, 32 employees received entries in compliance with MCSO Policy GB-2, *Command Responsibility*. Three of the employee records did not meet the inspection requirements.

Results of the Review of Employee Supervisor Note entries:

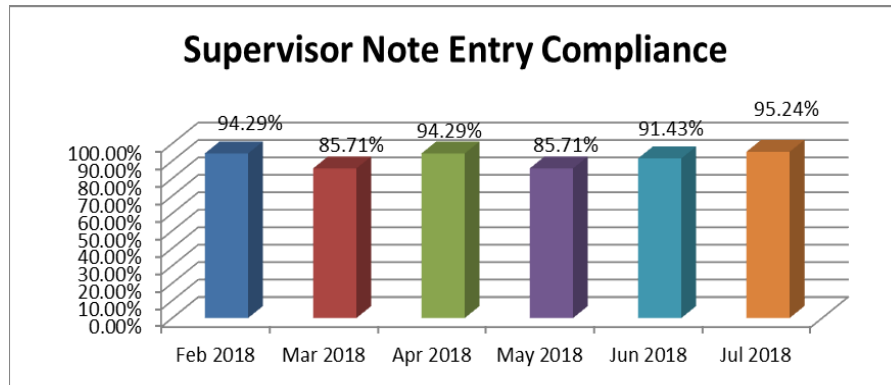
**The following Perceived deficiencies were identified during the inspection process and require that a *BIO Action Form* be completed.**

**PLEASE NOTE:** *The Supervisory Note Inspections represents a monthly snapshot in time and any deficiencies noted are the responsibility of the Supervisor and the Chain of Command at the time the entry was made. Any inaccuracies in command structure due to transfers or other changes are outside the control of the AIU.*

Below is the six month historical comparison of compliance rates for detention personnel Supervisory Notes entries.



**Recommendations:**

It is recommended that Management continue to provide on-site mentorship to supervisors regarding the importance of ensuring Supervisory Note entries are used to document a specific employee's performance and should be of sufficient quality as to give a true assessment of the employee's performance during a particular period, as required by MCSO Policy GB-2, *Command Responsibility*, Paragraph 7.B and its subparagraphs. To accomplish this goal, the Supervisory Note entries need to specifically document the following requirements:

- o The Employee's work performance during the last 30 day period.
- o Once per month, supervisor's review of non-sworn subordinates' EIS information for the purpose of identifying and responding to any conduct patterns or concerns.
- o Maintain a written record of the performance of each employee in the EIS Blue Team Supervisor Notes application. The record shall reflect the employee's positive traits and accomplishments and any observed shortcomings.
- o Supervisor Note entries shall be of sufficient quality and frequency to facilitate the preparation of an accurate and detailed performance review, but *at a minimum, one entry shall be completed every month.*

**Action Required:**

With the resulting **95.24%** compliance for *Inspection BI2018-0086*, a total of **3** BIO Action Forms are requested from the affected divisions. **The forms shall be completed utilizing Blue Team.** It is permissible to complete a single BIO Action Form for a supervisor addressing multiple perceived deficiencies identified in this inspection.
