The Audits and Inspections Unit (AIU) of the Sheriff's Office Bureau of Internal Oversight (BIO) will conduct monthly County Attorney/Justice Court Disposition Inspections.

The purpose of this inspection is to determine if the case was turned down due to an "irreversible error" and adherence to policy and law. Irreversible errors can be (but not limited) to the following; violations of civil rights, incorrect charges, untimely submitting of charge(s) resulting in exceeding the statute of limitations, or a case lacking proper investigation. Any error or combination of errors that occur as a result of actions or lack of due diligence on behalf of Office personnel that once committed cannot be reversed and may result or be a factor in a case being turned down or charge(s) dismissed.

Inspectors will utilize the "IAPro" program software to generate turndown dispositions entered into IAPro by the Early Intervention Unit (EIS) each month from the Superior Court and dismissals from the Justice Courts within the specific month to be inspected. The terms; "turndown" and "dismissals" are generic nomenclature (from the courts) and refer to a variety of court dispositions. No bias shall be implied or inferred as to the reason of the court disposition based on these generic terms.

These entries will be uniformly inspected by primarily utilizing the Records Division "FileBound" data base and a matrix developed by the AIU. Each complainant disposition inspected will be counted as one inspection. The following procedures, which are outlined in GF-5 and ED-3, will be used in the matrix:

Matrix Procedures:

- ➤ Determine if there were any "irreversible errors"
- Note what district/division from which the disposition originated
- ➤ Note the County Attorney disposition reason/type
- Note the Sheriff's Office method of charging (In-Custody, Citation, or Long-form)

MCSO Policy ED-3, Review of Cases Declined for Prosecution, provides a mechanism for command level review of the same cases involved in this inspection to identify/address minor issues and/or additional training issues/concerns that are outside the scope of this inspection.

Conditions:

All the County Attorney Turndown dispositions from the Maricopa County Superior Court for the month of May 2018 available in IAPro (33 total cases) were reviewed.

There were approximately 122 dismissals of criminal cases from the Maricopa County Justice Courts available in IAPro for that month. A random selection of 20 these cases were also selected for review.


It should be noted that the focus of this inspection is on the identification of "irreversible errors." During the inspection of the Superior Court and Justice Court turndowns; there was <u>1</u> irreversible error noted. This resulted in a <u>98%</u> compliance rate for May 2018.

Deficiency:

For reasons not articulated in the report, the case agent did not submit two counts (misdemeanor DV- Assault and misdemeanor DV- Criminal Damage) in a timely manner for an incident occurring on 4/8/2017. The case agent later authored a supplemental report on 3/17/2018, just short of a year later, submitting the case to the MCAO for review. The MCAO turned down prosecution on the case, citing "stale/old case". It appears the elements of both crimes were present to arrest or charge both suspects on the date of the event. If follow-up occurred to further the investigation; no documentation was located identifying such.
